### **Administrative History/Biographical Sketch**

The International Woodworkers of America were founded in 1937 when Canadian communist Harold Pritchett led delegates of a Federation of Woodworkers convention in Tacoma WA to join John L. Lewis's Congress of Industrial Organizations. As an international union, the IWA had offices and Local Unions across Canada and the United States, with a particular focus in the Pacific Northwest. Local Union 1-80 was based in Duncan, British Columbia, and covered an extensive territory on mid Vancouver Island from Parksville to Lake Cowichan.

The roots of I.W.A. Local Union 1-80 predated the formation of the International Union. Organizers associated with the Lumber Workers Industrial Union began organizing in camps around Lake Cowichan in the early 1930s, leading to the formation of the first unionized logging camp in British Columbia at Lake Logging Company in 1934. An influential Ladies' Auxiliary was subsequently formed in 1935.

After the founding of the I.W.A., the local union affiliated with the International Union's District 1, and received their charter and designation as Local 80 in 1937. The next decade saw the Local Union grow in size and influence, signing a collective agreement with Lake Logging in 1941 that contained the first closed-shop provision in the Canadian lumber industry. In 1946, a 37-day provincewide strike secured great improvements in working conditions and security, as well as guaranteeing a shorter work week. Local 1-80 and its Auxiliary played a key role in this strike, including organizing and leading a trek of 3,000 union members to Victoria.

Local 1-80 was particularly hard hit by the "White Bloc/Red Bloc" struggles that gripped I.W.A. District 1 towards the end of the 1940s. Communist-leaning union executives, in part resenting the influence of the Portland-based International Union, decided to split from the I.W.A. and formed the Woodworkers Industrial Union of Canada in 1948. Key members of Local 1-80's executive, including President Owen Brown and Financial Secretary Fred Wilson, participated in the split. However, the union's rank and file voted to reaffiliate with the I.W.A. following the split, leading to many of the W.I.U.C. leaders being blacklisted.

Throughout the twentieth century, Local Union 1-80 played an influential role in the I.W.A., and worked tirelessly to secure better working conditions and wages in the Cowichan area. As the lumber industry's prosperity in the 1950s and 1960s tailed into economic plight and job losses in the 1970s and 1980s, the Local remained on the frontlines battling to protect jobs. Executives formed a "Woodworkers' Survival Taskforce" in 1989, which pressured forest companies to adopt less wasteful practises, and led

an active series of campaigns and blockades targeting raw log exports throughout the 1990s. The Local was also at the heart of several key environmental conflicts in this period due to its proximity to the Carmanah and Walbran Valleys.

However, the combination of globalizing trade, technological advancement, and environmental pressures led to mill closures and mass job losses in the industry, which in turn decimated I.W.A. membership. This led to the union to re-organizing structurally. Local 1-80 absorbed Victoria's Local 1-118 in 1989. In 2004, I.W.A.-Canada members voted to merge with the United Steelworkers of America, ending the functioning of union as a distinct entity. Local 1-80 continued to operate from the same office, under United Steelworkers Local 1-1937.

### **Scope and Content:**

The fonds consists of the surviving records I.W.A. Canada Local 1-80, as well as the early records of the Lake Cowichan I.W.A. Ladies Auxiliary #20. These records were created in operations throughout the Cowichan Valley, stored in the Local Union office in Duncan, and encompass a time period that stretches from the early organizing efforts of the 1930s until the Steelworkers merger in 2004. They include files created in the administrative functioning of the Local Union and in its campaigns and interactions with employers, as well as files and publications created by several incarnations of the Local Union newspaper.

Also included in the fonds is a legacy archive collected by Local Union executives, as well as the papers of several key union figures. These include: the records of Bill Routley, 1<sup>st</sup> Vice-President between 1988 and 1990 and President between 1990 and 2009; Edna Brown, Ladies' Auxiliary #20 Secretary-Organizer between 1935 and 1938 and President of the I.W.A. British Columbia District Council Auxiliary between 1938 and 1948; and Allan Lundgren, 1-80 Safety Council member between 1978 and 2002 and local union archivist between 1990 and 2002.

Materials contained in this fonds include: minutes books, financial ledgers, letters and correspondence, facsimiles, reports, books, newspapers, magazines, press clippings, notes, agreements, by-law booklets, and conference/convention proceedings.

### **Notes:**

**Physical Condition:** Surviving records are generally in good condition, although some older materials are damaged and worn due to improper storage. Most of the Local Union's records prior to 1948 are presumed to have been destroyed in the aftermath of the "red-bloc/white-bloc" disturbances.

**Immediate Source of Acquisition:** The United Steelworkers of America Duncan Local 1-1937.

**Arrangement:** The fonds is divided into three sous-fonds, which represent three waves of collections and acquisitions made by the Kaatza Station Museum and Archives over the last 30 years. See each series description for more information on the chronology of said acquisitions. Where identifiable, original order has been maintained. All records are reflected in the intellectual arrangement described above, and some records in the same series are physically located in different locations in order to retain original order. Where present, file names have been preserved.

### **Custodial History:**

Local President Roger Stanyer began the Local 1-80 legacy archive in the mid-1970s when the union began collecting photographs which had been donated by 1-80 members. The purpose of the archive was to collect and preserve written records and photographs detailing the history of the Local Union and the broader I.W.A. Ken McEwan (editor for the Local's newspaper, the 1-80 Bulletin, starting in 1969) took over archival responsibilities after Stanyer had established the archive. In 1983, the Wilmer Gold photograph collection was purchased by Local 1-80 and stored in the Local 1-80 office in Duncan. Allan Lundgren began caring for the archives after McEwan was released from his position in the 1980s. In the late-1990s Lundgren became the official archivist for the Local 1-80 archives.

In 2007, the Wilmer Gold photograph collection was moved from the Local 1-80 office in Duncan to the Kaatza Station Museum and Archives in Lake Cowichan. In 2010, the paper records held in the archive were also moved from the Local union office to the Kaatza Station Museum and Archives after the merger of Local 1-80 and the United Steelworkers. At this time a formal archival project was begun but was abandoned roughly halfway through. In early 2020 the project was formally restarted and completed by John Mountain, Henry John, and Kaden Walters.

### **Scope and Content:**

The records from the 1-80 legacy archive contain files relating to the history of the I.W.A. and the 1-80 Local collected by union members. Also included are select administrative files and records produced as a result of relations between the Local Union and the forest industry, as well as files related to Local Union balloting and elections. This sous-fonds also contains files relating to the welfare of employees represented by the I.W.A., a series of documents on forestry and land use, and a large collection of documents of the Local I.W.A.'s presence in the media and in the public.

This sous-fonds contains the personal files of Edna Brown, as well as her files relating to the administration of the Lake Cowichan and the British Columbia District 1 Ladies' Auxiliary of the I.W.A. Allan Lundgren's files largely contain files related to his efforts to improve the safety and

forestry practices of logging operations, as well as well as files related to his administration of the legacy archive.

**Notes:**

Physical Condition: The records are in overall good condition although the older documents printed on newspaper have begun to show ageing through discolouration of the paper. Other documents were produced on thin paper, and have become delicate.

Immediate Source of Acquisition: International Woodworkers of America Local 1-80

Arrangement: The legacy archive was located in the Local 1-80 office in Duncan from their creation in the mid-1970s to their move to Lake Cowichan in 2010. Despite this, the archive has had multiple caretakers over the years who reshuffled the files on various occasions. The team who began the archival process after the acquisition of the files in 2010 began to arrange the files but only finished about half of the arrangement before the project was abandoned. Much of the current arrangement was interpreted and reworked from this arrangement, despite much of the original order having been lost by this time. File titles have been preserved where they existed, but many files were unnamed, and as such had to be given a name that best reflected the contents of the file.

**Series 1: The Edna Brown Papers (2020.012-1.1)**

Dates: 1935-1991

Biographical Sketch: Edna Brown was a central figure in the early organization of women's labour in the Cowichan Valley and British Columbia. She was a driving force behind the formation of the Lake Cowichan Ladies' Auxiliary #20 in 1935, which would eventually become attached to the I.W.A. in 1938. She served as Secretary Organizer for Auxiliary #20, and eventually went on to lead the I.W.A. British Columbia District Council Auxiliary between 1938 and 1948. Brown and the Ladies' Auxiliary were heavily involved in the struggle to better the living and working conditions not just for I.W.A. members in Lake Cowichan but for the community as a whole.

Scope and Content: The series contains the files of the Lake Cowichan Ladies' Auxiliary, and primarily deal with the administration and meetings of the Auxiliary. It contains Auxiliary membership cards, financial records, and meeting minutes. Other records relating to Local 1-80 and the Regional I.W.A. which deal with other Auxiliaries and by-laws are also included in this series. There are also various published materials from Local 1-80 and the Ladies' Auxiliary in this series. Lastly, the series contains the record of Edna Brown's son, Bill Brown, donating Edna Brown's files to the Local 1-80 archives.

Record types contained in this series include financial records, membership cards, minutes, reports, letters, by-laws, and various print media including newspapers and booklets.

## **Series 2: The Al Lundgren Papers (2020.012-1.2)**

Dates: 1951-2003

Biographical Sketch: Allan Lundgren began working as a faller alongside his father in the 1960s. His father, Henry Lundgren, had been an early member of the I.W.A., and was a vocal advocate for better working conditions and safety practices for fallers. Allan worked in forestry for decades, and was also an advocate for safety. He sat on the Local 1-80 Safety Council from 1978 until his retirement in 2002. In that time, he had greatly raised the standard of safety for local logging operations. His most lasting work was the B.C. Faller Training Standard which was adopted in 2004 across British Columbia, in the oil industry, and was exported abroad as well. He was also the archivist for Local 1-80 from around 1990 to 2002.

Scope and Content: The series contains files produced by Lundgren during his various responsibilities with the Local Union and beyond. It contains records produced and collected by Lundgren in his capacity as union archivist and as a member of the 1-80 Safety Council, as well as other records created through his involvement in reforming safety and forestry practises throughout the industry. The series also holds files produced by Lundgren in his work as a consultant and trainer for the B.C. Faller Training Standard, as well as various publications collected by Lundgren over the years.

Record types contained in this series include correspondence, photographs, minutes, reports, surveys, training manuals, contracts, questionnaires, notes, presentation slides, and various print media including booklets and newsletters.

### **Custodial History:**

The administrative records of Local Union 1-80 were produced through the functioning of the union office and wider apparatuses. These records were stored in the basement of the office of the Local Union (now under the banner of United Steelworkers Local 1-1937 following the 2004 merger) on Brae Road in Duncan, British Columbia, either in filing cabinets lining the sides of their meeting room or in the so-called “Snake Pit” storage room. Archivists Henry John and John Mountain acquired the records on behalf of the Kaatza Historical Society in the summer of 2020. The records are held by the Kaatza Station Museum and Archives as a two-year loan, with the option of either renewal or permanent acquisition in the summer of 2022.

### **Scope and Content:**

The Sous-Fonds contains the administrative files of I.W.A. Local 1-80, largely between 1948 and the merger of the I.W.A. and the United Steelworkers in 2004. This includes the financial and administrative records of the Local Union and its respective Sub-locals, an extensive collection of files created through the Local Union’s interaction with companies, and a relatively complete collection of the Local Union newspaper beginning in 1963. Also contained within are files created during special campaigns waged by the Local Union, including those related to raids by the Pulp and Paper Workers of Canada, raw log exports, and the Greater Victoria Water District.

Materials contained in this Sous-Fonds include: correspondence, email and fax printouts, reports, meeting minutes, financial ledgers, by-law booklets, agreements, forms, newspapers, bulletins, posters, and publications. Occasional photographs are dotted throughout, however by-and-large the Sous-Fonds is almost exclusively textual material.

### **Notes:**

Physical Condition: The records itemized here are in good condition. Most records predating the 1948 W.I.U.C. split are missing and presumed destroyed.

Immediate Source of Acquisition: United Steelworkers Local Union 1-1937.

Arrangement: The original order of the records has been preserved where possible. In a few cases where the original order was not visible, archivists arranged the records to reflect the administrative structure of the Local Union.

Related Material: The records contained in this Sous-Fonds interact and overlap with records contained the Sous-Fonds 1, the I.W.A. 1-80 Legacy Archive. See series descriptions for more information on these linkages.

Further Accruals: Further accruals are expected at a later date. These will include: an extensive collection of membership dues cards and a large collection of company correspondence, both of which are stored in the United Steelworkers 1-1937 basement. Another potential future accrual will be the Executive Board Meeting Minutes between 1963 and 1970, as well as between 1979 and 1991, which were unable to be found.

### **Biographical Sketch:**

Born in 1948, Bill Routley served as a New Democratic Party Member of the Legislative Assembly of British Columbia following an extensive and successful career as a labour organizer with the International Woodworkers of America. Routley began working at the British Columbia Forest Products mill in Youbou in 1970, and subsequently served both on the operation's Safety Council and as the Chairman of the I.W.A. Plant Committee. He was hired as a Business Agent by Local 1-80 in 1985, and was elected 1<sup>st</sup> Vice-President of the Local Union in 1986. Following the departure of Roger Stanyer in 1990, Routley was elected President of the Local Union. He held this position until 2009, when he was nominated to run for the position of Cowichan Valley M.L.A., which he won and held until 2017.

During his career with the I.W.A., Routley was at the heart of many of the events that determined the fate of the union. He helped form the Woodworkers' Survival Taskforce in 1989, with the aim of holding forestry companies accountable for poor logging practises, wood waste, and job losses. This focus on forestry practises characterized the rest of Routley's career with the I.W.A., with raw log exports and industry safety practises dominating his campaigning. Routley had a mixed relationship with the explosion of environmentalism that characterized the 1980s and 1990s, and was outspoken in his criticism of preservationist campaigns in Carmanah, the Walbran, and Clayoquot Sound. Despite this, he also took efforts to find common ground with environmentalists, and was the driving force behind the South Island Forest Accord, signed between the I.W.A. and environmental groups in 1991.

### **Custodial History:**

The records were stored in the basement of the United Steelworkers 1-1937 office in Duncan. In 2020 archivists John Mountain and Henry John acquired on loan records that ran until the merger of the I.W.A. and U.S.W. in 2004, housing this section of the records at the I.W.A. Archive at the Kaatza Station Museum and Archives.

### **Scope and Content:**

The Sous-Fonds contains Routley's records produced in his various roles with the International Woodworkers of America, from being Youbou Mill I.W.A. Plant Chairman through his tenure as



President of Local Union 1-80. At the request of the current officers of U.S.W. 1-1937, records covering the time period following the 2004 union merger were left in the Duncan office's basement for later accrual. The Papers cover files and other materials produced in the administration of both the Local and Regional I.W.A., records produced during Coast Negotiations, files produced in interactions with both companies and various levels of government, and files devoted to special topics such as environmentalism and forestry practises.

Materials contained in this Sous-Fonds include: correspondence, email and fax printouts, reports, meeting minutes, agreements, forms, newspapers, bulletins, and publications. Occasional photographs are dotted throughout, however by-and-large the Sous-Fonds is almost exclusively textual material.

### **Notes:**

Physical Condition: The records itemized here are in good condition.

Immediate Source of Acquisition: United Steelworkers Local Union 1-1937.

Arrangement: Due to the records being placed in storage indiscriminately over multiple time periods, the original order of the files was not identifiable. Archivists subsequently imposed their own order, which reflect the key functions of Routley's activities. Organization of files according to the role held by Routley at the time was not possible, due to multiple files being created and added to over an extensive period of time, during which time he held several different positions. All records are reflected in the intellectual arrangement described above, and some records in the same series are physically located in different locations. Where present, file names have been preserved.

Further Accruals: Several boxes from the early 2000s remain unarranged at the Kaatza Station Museum and Archives, and will be added to the collection in 2021. Several boxes of records from Routley's tenure as President following the 2004 merger remain stored in the Duncan office of the U.S.W., and will be acquired once Local Union officers are comfortable parting with them.
