Administrative History/Biographical Sketch

The International Woodworkers of America were founded in 1937 when Canadian communist Harold Pritchett led delegates of a Federation of Woodworkers convention in Tacoma WA to join John L. Lewis's Congress of Industrial Organizations. As an international union, the IWA had offices and Local Unions across Canada and the United States, with a particular focus in the Pacific Northwest.

Local 1-217 was the Vancouver local of the union. It was chartered in 1937, and the Red Band Shingle Plant was its first operation organized. Initially Local 1-217's jurisdiction covered both Vancouver and New Westminster, until Local 1-357 took over New Westminster when it was founded in 1943.

In 1948 a split of the I.W.A. in British Columbia came about due to infighting between "white-bloc" and "red-bloc" factions. Executives embittered at the influence of the American-based International Union, including union founder Pritchett, formed the Woodworkers' Industrial Union of Canada and proceeded to physically take over I.W.A. Local offices. Although the pro-International "white-bloc" eventually resumed control, all Local Union 1-217 records prior to 1948 were destroyed during the tumult.

I.W.A. Local 1-217 served as one of the I.W.A.'s largest local unions, representing woodworkers and other workers in multiple large Vancouver-based operations, including MacMillan Bloedel's Red Band, Canadian White Pine, and Particle Board plants. By the 1950s the local union represented upwards of 7,400 workers, and throughout the 1960s, 70s, and 80s staged several large strikes.

By 1998, after two decades of massive job losses and plant closures in the forestry section, the decision was taken for the 1-217 to merge with the "Loggers Local" 1-71, forming IWA-Canada Local 2171. However, the Vancouver local union office continued to function as a discrete administrative unit. In 2004, I.W.A.-Canada members voted to merge with the United Steelworkers of America, creating the largest private sector union in Canada and ending the administrative function of the I.W.A.'s Vancouver Local Union.

Scope and Content:

The fonds consists of surviving Local Union 1-217/2171 records, as created and stored in their office in Vancouver BC. It contains the personal records of local-union officers and staff, as well as records relating to the main functions of the local union, including: meeting minutes, correspondence, committee records, records created by the 1-217's activities at various plants and companies, forestry research projects, and publications stored at the office.

Also contained in the fonds are the records of the I.W.A. Local 1-217 Ladies Auxiliary, as well as the records and publications produced by the Local Union's newspaper team, initially under the title *The Conveyor* but later changing names to *The Barker*. The fonds also contains records produced by local union members and staff in their interactions with the District/Regional Council and the International headquarters of the I.W.A.

Notes:

Physical Condition: Surviving records are in good condition. However, the Local Union's records prior to 1948 are presumed to have been destroyed during the "red-bloc/white-bloc" disturbances. Furthermore, during their transition from Vancouver to Lake Cowichan, some of the records suffered serious water damage and hence were destroyed, without a record being taken of their function or their number.

Immediate Source of Acquisition: The United Steelworkers of America District 3

Arrangement: Before being housed at the Kaatza Station Museum and Archives, the records were moved between offices and between cities on multiple occasions. Over several moves, with volunteers sorting and resorting at each stage, much of the original order was lost. Where identifiable, original order has been maintained. Many of the records arrived in disarray and have been rearranged by the archivists, according to the categories implemented in the Local Union filing system. All records are reflected in the intellectual arrangement described above, and some records in the same series are physically located in different locations in order to retain original order. Where present, file names have been preserved.

Series Descriptions:

Series 1: Local Union 1-217 Officer and Staff Personal Files (2020.004-1)

Date: 1950-2000

Scope and Content: The series contains the records of 1-217 officers and staff, which were filed separately to the Local Union's main filing system. They include both union-related and personal files. Included are the records of Lloyd Whalen (President from the 1940s until 1958) and a large collection of records belonging to Financial-Secretary and later Commissioner of the Northwest Territories Stuart Hodgson. Hodgson's files contain correspondence, meeting minutes, and research, as well as records created in his position as Chairman of the IWA International Committee to Implement Resolution 26 and Chairman of the I.W.A. B.C. District #1 Publicity Committee.

The series also contains the records of Local Union President Syd Thompson in his capacity as Financial Secretary for the 1967/1968 Fisherman’s Defence Fund, a solidarity fund for striking members of the United Fisherman and Allied Workers Union. Also contained in this series are the records of Financial Secretary Doug Evans and business agents Erich Ewert and Jim Parker. Finally, this series also contains the records of Gary Wong, Director of the Forest Workers Transition Program, which operated out of the Vancouver office of the Local Union between 1996 and 2000.

Record types contained in this series include correspondence, email and fax printouts, minutes, convention materials, financial records, and newspaper clippings.

Series 3: I.W.A. Local Union 1-217 Communications (2020.004-3)

Date: 1948-1982

Scope and Content: The series contains records from the 1-217 created as the office communicated both with its own membership as well as with bodies external to the Local Union. Examples of such external authorities include the Regional and International councils of the I.W.A., other I.W.A. local unions, the B.C. Federation of Labour, Forest Industrial Relations, and different levels of Provincial and Federal governments. Record types contained in this series includes correspondence, press releases, notices, and flyers.

Arrangement Note: This series attempts to follow the filing categories implemented in the original order of the records. However, due to the disorganization of the records much of this order needed to be reconstructed. Union communications can also be found in Series 1 (Officer and Staff Personal Files) if they were originally filed there. Correspondence with companies and plant management under Local Union jurisdiction can be found in plant and company files (series 5) as this was predominately filed separately to other correspondence in the original order.
